Capital Proposals:

These proposals could be funded from the £1.5m underspend identified in the 2023/24 Revised Budget. It is assumed that the estimates listed for each proposal are sufficient for the works listed.

Revenue Proposals:

I note that the revenue costs proposed will end at the end of 2026/27 ie a three year fixed period. Based on this assumption this expenditure could therefore also be funded from the £1.5m underspend. It is worth noting any fixed term post beyond two years would be entitled to a redundancy payment.
